## Training Requirements of Subchapter M

**Subchapter M** requires that the Towing Vessel's Master must <u>ensure</u> that the crew has the knowledge, understanding and proficiencies needed to properly:

- Abandon the vessel;
- Recover persons from the water;
- Respond to onboard fires and flooding; and
- Respond to other threats to life, property or the environment.



#### Occupational Health and Safety (§ 140.515)

The Towing Vessel Operator must provide all crewmembers with health and safety information and training that includes:

- Content and procedures of the owner or managing operator's health and safety plan;
- Procedures for reporting unsafe conditions;
- Proper selection and use of PPE appropriate to the vessel operation;
- Safe use of equipment including deck machinery, rigging, welding and cutting, hand tools, ladders, and abrasive wheel machinery found onboard the vessel;
- Hazard communication and cargo knowledge;
- Safe use and storage of hazardous materials and chemicals;
- Confined space entry;
- Respiratory protection; and
- Lockout/Tagout procedures.

#### Navigation Safety Training (§ 140.645)

Crewmembers who serve as lookouts and are not credentialed as an officer or Able Seaman must receive training to ensure that they are familiar with:

- Watchstanding terms and definitions;
- Duties of a lookout:
- Communication with other watchstanders;
- Change of watch procedures;
- Procedures for reporting other vessels or objects; and
- Watchstanding safety.
